Registrations will be accepted at the door, however, we may not have sufficient copies of The Blue Thumb Guide to distribute at that time, and you will need to pick your book up at the SWCD office after additional copies are obtained.

Green infrastructure applications and approaches can reduce, capture, and treat stormwater runoff at its source before it can reach the storm drain system. Site-specific practices, such as tree planting, downspout disconnections, **rain harvesting/gardens**, permeable pavers and natural landscaping are designed to mimic natural hydrologic functions and decrease the amount of water resistant area and stormwater runoff from individual sites.



Directions

From Sellersburg: Follow Hwy. 31 to its intersection with Hwy. 403 (at Silver Creek schools complex); travel approximately 2 miles; Earth First is on the left

From Charlestown: Follow Hwy. 403 approximately 4 miles from its intersection with Hwy. 3 ; Earth First is on the right

From Jeffersonville: Take Hwy. 62 towards Charlestown; turn left on Salem Noble Rd.; follow Salem Noble to its intersection with Hwy. 403 and turn left; Earth First is immediately on the right
